#### Terms & Conditions Sydney FC Junior Blues Membership:

1. A Junior Blues Membership card will, subject to these terms and conditions, admit its registered holder into general admission (Bronze) areas at regular 2010/11 Hyundai A-League Season Sydney FC home games on presentation of the card at the relevant match venue. The card does not provide any right of admission to 2010/11 Hyundai A-League Finals Series or Asian Champions League
2. If a junior football player seeks to apply for the Junior Blues Membership, he or she must first obtain the permission of a parent, teacher or other responsible adult, to apply for the Junior Blues Membership and provide the personal details required in the registration process.
3. A Junior Blues Membership card is not transferable and may only be used by the junior football player to whom it is registered. The right of admission granted to the registered holder is subject to:
  - a. the venue not being full or subject to some other capacity constraint;
  - b. the right of Sydney FC to refuse access for selected games;
  - c. the conditions of entry for that match venue.
4. Sydney FC may at its sole discretion cancel application for any Junior Blues Membership card, including if the card is dealt with in any way contrary to these terms and conditions.
5. Sydney FC does not provide supervision of Junior Blues Members at Sydney FC home games. If you are a parent, teacher or other responsible adult applying for the Junior Blues Membership card on behalf of a junior football player, you acknowledge that it is the sole responsibility of the parent or legal guardian of the Junior Blues Member to ensure that he or she has such supervision as is required.
6. Sydney FC will send confirmation that the application for the Junior Blues Membership has been approved or declined, and information about capacity and access to games, to the email address nominated on registration. Sydney FC may contact the holder at the nominated email address with offers and information from time to time. Should you wish to opt out of receiving this information, details of how to do so will be provided in the emails.
